## BVI BIDS FAREWELL TO NORWELL ELTON HARRIGAN

A memorial service celebrating the life of the late Norwell Elton Harrigan better known as Tony was held on 10 May at the St. George's Episcopal Anglican Church.

Tony was born on 9 March, 1946 to the late Dr. Norwell and Beatrice Harrigan. He had two siblings: Peta Harrigan Cole, and the late Philip Gregory Harrigan. He attended the Road Town Primary School and completed his secondary

education at Bristol Cathedral in Wales, United Kingdom. Upon graduation, he returned to Tortola. Two years later he was admitted to the University of Pittsburgh in Pennsylvania to pursue a baccalaureate degree in political science and completed his studies at Lincoln University where he earned a Masters Degree in Human Services.

He met his bride-to-be, Dr. Birney Harrigan, when she was a senior in high school, and never stopped talking about that magical moment they met on Thursday, 25 March, 1965 at his sister-in-law, Lola and the late George Malone's wedding. He loved every opportunity to tell the love story about that ordained encounter with so much joy and exuberance. That was the beginning of the most amazing 59-year journey together.

Together they had the most beautiful daughter, Nadja, their pride and joy. Tony had a very special relationship with Nadja; he was the one she would talk to and seek his wise counsel. He was her hero, friend, and confidant. They enjoyed conversing and watching sports together. He was an avid Pittsburgh Pirates and Steelers fan. He took Nadja to her first Pirate baseball game when she was an infant. Nadja had a learning-rich life, with much support from her dad. It began with daycare where Tony was president of the parent association and never stopped.

Tony remained in Pittsburgh with his spouse and daughter Nadja for almost 40 years, before returning home to the BVI in 2004. Upon his return, he served as the Human Resources Manager at both Road Town

Wholesale, and at Scrub Island Resort. His father, Dr. Norwell Harrigan was the Chairman of the Board of Directors of The Island Sun newspaper; after his death his son Tony became the Chairman of The Island Sun newspaper.

During his working years, Tony also served as a Career Counselor for Jewish Family and Children Services; as Director of the Independent-Alternative Program Associates; as Family and Children Services Coordinator at the Council of Three Rivers American Indian Center; and as Senior Therapist for Whales Tale, among others. His professional objective was always to promote transformational learning through continuous self-assessment and improvement.

In 2005, Nadja blessed her

parents with a miracle child, Qian-Harrigan-Thomas. Tony always said being a grandparent is a chance to be a better parent. As Pop Pop, it was such a joy for Tony to witness Qian growing into the beautiful person he intended to be. They were both looking forward with great enthusiasm to watching the NFL draft in April. Almost every night Qian would call his Pop Pop in Miami and they would speculate about the Steelers' optimal picks in the draft, but Pop Pop never made it home alive. Sadly Tony won't be here to see Qian walk across the stage for his high school graduation this month, nor to see him off to college this year. Nonetheless, the family is comforted by the fact, that he would be with them in spirit.

## HIGH TECH TO PROTECT BVI BORDERS

Premier and Minister of Finance, - Dr. the Hon. - Natalio Wheatley-disclosed that the Government is considering technology as a border security enhancement measure. Hon. Wheatley who made the disclosure during the House of Assembly sitting on 2 May stated that the intention is to use technology to protect the Territory's porous borders. It was opined that the technology will help the BVI to combat illegal immigration and smuggling.

The Premier's announcement came in response to a query from Opposition Leader Hon. Ronnie Skelton, who sought clarification

on the measures in place to prevent illegal immigration, trafficking, and the smuggling of contraband into the BVI. Premier-Wheatley affirmed that securing the Territory's borders is a government priority. He highlighted the importance of ongoing cooperation with regional counterparts, particularly in the US Virgin Islands, St Maarten, Antigua, and Puerto Rico, to share intelligence and strategies related to illegal migration.

"Madam Speaker, we spoke a little about collaboration with our neighbours, which is very important. As you know, we have very vulnerable borders and we sometimes

have vessels moving in between the different islands, whether it be St Maarten or US Virgin Islands...and we do have a challenge that we have to address, in terms of our border management," Premier-Wheatley explained.

-To address these challenges, - the government is considering

the use of cutting-edge technologies such as radar and satellite systems. Additionally, there are plans to merge the Immigration and Customs departments into a single border agency, which will require significant investment in maritime resources.

"Without a shadow of a doubt, we certainly

will have to employ technology, given the vastness of our marine borders and we will have to invest in more assets on the water," Premier Wheatley stated.

He also mentioned that the government would address further measures detailed in the Law Enforcement Review to strengthen border security.

## INDISCRIMINATE GARBAGE DUMPING EXASPERATED RECENT FLOODS

Last Wednesday 8 May public schools were closed and many government offices' were affected due to an inclement flooding situation, which Minister for Works and Utilities Hon. Kye Rymer-announced was exasperated by indiscriminate garbage dumping by some residents in the Territory.

Hon. Rymer disclosed that the severe flooding, which caused significant infrastructural damage across the BVI is a warning of what happens when improper waste disposal persists.

Following the flooding, teams have been actively engaged in clean-up operations across the Territory, focusing on critical areas such as the market square, the Elmore Stoutt High School, West End, and Windy Hill. Despite these efforts, the flooding led to widespread, albeit mostly minor, infrastructural damage. Nothing to compare to the recent tornados and floods in Florida.

While noting that the flooding should be blamed on poor dumping practices, the Minister revealed that clean-up teams following the flood found large household

appliances and other debris obstructing drainage-systems, exacerbating the flooding issue. "Help us to help you because where we are doing our assessment, we are seeing that there are actual washing machines, we are seeing mattresses and all sorts of debris in the ghut. So we are asking persons to refrain from that kind of behaviour," Hon. Rymer pleaded.

The Utilities Minister noted that further assessments are necessary to fully understand the extent of the flooding damage.-"Initial assessments-showed that the

damage to infrastructure was mostly minor, with some areas experiencing minor flooding," he stated.

The recent heavy rains also disrupted ongoing roadwork projects, which had to be temporarily halted. "It's unfortunate that we were actually out doing patching... when we thought that it was just a small rain, it turned out to be excessive," Minister Rymer explained. Despite this setback, he assured residents

that road repair efforts would continue. "We will continue to do our road patching. Our asphalt plant is up and working, and we will be out trying to make the roadways as passable as possible."

## CTL OWNER CRITICIZES LABOUR DEPARTMENT

Michael-Thomas, Managing Director of Clarence Thomas Ltd, has publicly criticized the Labour Department, accusing its staff of acting beyond their roles and causing unnecessary delays in the work permit process. Mr. Thomas shared his frustrations on the Talking Points radio show, highlighting ongoing issues his company faces with work permit renewals and approvals.

"I have a problem with Labour... because I think that some of the people in the Labour Department are basically trying to do what they want to do and want to interpret the laws the

way they want to interpret them," the CTL executive said, emphasizing his frustration with the department's handling of basic issues.

The business owner who said that he firmly believes in the notion of "BVI Islanders first" and supporting the local workforce, stressed the importance of hiring international staff to meet his company's needs. He stated that Clarence Thomas Ltd employs a diverse workforce, including many BV Islanders and Belongers. However, -Thomas argued that the Labour Department's actions are hindering his business's

growth.

"For my business to succeed, for me to continue paying the taxes that I keep paying in this country, for me to continue employing the people I employ in this country, I need the ability to bring people into the country to work," Thomas explained.

Thomas recounted a recent incident where the Labour Department refused to renew a work permit for an employee who had been with the company for over four years, forcing them to incur additional costs at the Immigration Department. The department cited the Human Resources

Manager's lack of authority to sign off on the renewal as the reason for the refusal. "I'm like, what kind of ignorance is this?" Thomas exclaimed. The business owner also criticized the Labour Department for failing to support workforce development. "They talk about workforce development. How are you helping me to develop my business when you've given me more stress and trouble?" he questioned.

Thomas called for greater accountability and adherence to legal protocols within the department. "We're either going to get people in here to do the work that

needs to get done, or we need to hold our people accountable. We've got to stop treating this country like it's yours. That's not your department. You have a job to do. If the law says do X, then do that," he asserted.

Thomas's comments highlight the challenges local businesses are faced with to expedite the work permit process, calling for more supportive streamlining.

## Crown Lands Management Bill Gets First Reading In The House

The Premier and Minister of Finance, Honourable Dr. Natalio Wheatley, is urging the residents of the Virgin Islands to pay attention to the Crown Lands Management Bill, as it received its first reading in the House of Assembly on 2nd May 2024.

This Bill outlines clear criteria and processes for the disposal and leasing of Crown Lands, ensuring that decisions made in relation to lands are transparent and in the interest of the community.

Premier Wheatley stated, "I am pleased to present

to this esteemed House a comprehensive Crown Lands Management Bill, which has been developed with careful consideration of our historical context, current challenges, and future aspirations. This Bill is not merely a set of rules and regulations, it is a road map to sustainable development, social equity and environmental stewardship."

Some of the key components of the Crown Lands Management Bill include sustainability, affordability, suitability of lands for development,

eligibility criteria and responsible management. The Bill also mandates the establishment of a periodic Land Use Plan, which will help shape the future of land allocation, planned communities, and mitigate the adverse impacts of unsuitable development.

The Premier further stated, "We recognise the delicate balance between economic growth and environmental protection, and our approach reflects a commitment for guarding our natural resources, for generations to come."

Meanwhile, the Permanent Secretary in the


Ministry of Environment, Natural Resources and Climate Change, Dr. Ronald Smith-Berkeley, further urged the Virgin Islands community to read the Crown Lands Management Bill and become acquainted with its content.

According to Dr. Smith-Berkeley, "The Virgin Islands Crown Lands Management Bill holds significant importance in determining the future development and prosperity of every Virgin Islander. Hence, it is highly recommended for all members of the community to thoroughly

peruse the Bill, which has already received its initial reading in the House."

The Crown Lands Management Bill governs the administration, management, development and use of all Crown and for all purposes and focuses on strengthening the transparent administration and management of Crown land, including the disposal of lands.



## Statement by Honourable Lorna G. Smith, OBE On Concerns Raised About Republic Bank (BVI) Limited Transactions

### Concerns Raised About Republic Bank (BVI) Limited Transactions

The Government of the Virgin Islands is aware of recent developments at Republic Bank (BVI) Limited, which resulted in the withdrawal of funds from several customer accounts. These withdrawals stemmed from the bank's delayed completion of processing

for approved point-of-sale and e-commerce transactions where customers had already received the authorised goods or services.

Following public concerns, I met with the Financial Services Commission (FSC), the regulatory body overseeing the bank, to discuss the situation. The FSC assures us they are

working with Republic Bank (BVI) Limited to find solutions. Affected customers can expect further communication from the bank outlining steps to address the issue. This follows the bank's May 2nd media release

where they committed to working with customers and offered options like payment plans. I encourage affected customers to visit the local branch for assistance.

While the Government

does not directly control the bank, we understand the community's concerns. As the Minister responsible for banking, I will continue working with the FSC to ensure a swift resolution is implemented once finalised.

# GLOBAL NEWS BRIEF

**EUROPE** - Climate change risks erasing the progress made in public health over the last 50 years.

Over 30 years - from 1990 to 2022 - there has in fact been a gradual increase of 9% in heat-related deaths, and this increase reaches 11% in southern Europe, including Italy, with a growth of 41% of the number of extreme heat days. These are the alarming data from the second edition of The Lancet Countdown in Europe 2024 report, which tracks progress on health and climate change on the continent. The Lancet, one of the most authoritative scientific journals in the world, annually publishes the results of The Lancet Countdown project at a regional and global level, to inform governments and the United Nations. Considering the links between climate change and health across the region, the new report explores 42 indicators that monitor the impacts of climate change on health, as well as inadequate, delayed or missed opportunities for climate action in Europe.

The picture described is worrying: in 2021, moderate or severe food insecurity affected almost 60 million people in Europe; for 11.9 million of these, insecurity is attributable to a greater number of days of heat waves and months of drought. Furthermore, in 2022, economic losses due to extreme climate-related events were estimated at 18.7 billion euros. [ANSA]

**SWITZERLAND**- Nemo arrived at Zurich Airport, where he signed autographs for fans and posed for selfies. The 24-year-old won this year's Eurovision contest with a song focusing on the performer's non-binary identity. Nemo Mettler was given a hero's welcome when they returned to Switzerland from Sweden after winning the Eurovision Song Contest contest on Sunday. Hundreds of fans waving flags and banners and chanting the 24-year-old's name greeted Nemo as he flew into Zurich Airport.

Nemo won Eurovision 2024 with the deeply personal song "The Code," which encapsulated the



performer's journey to realizing his non-binary gender identity. Nemo [pictured above], who now lives in Berlin, is from Biel (in French Bienne) in northwestern Switzerland, the country's largest bilingual city and the heart of the Alpine nation's watchmaking industry.

The city is planning an official public reception to honor its hometown hero [Deutsche Welle]

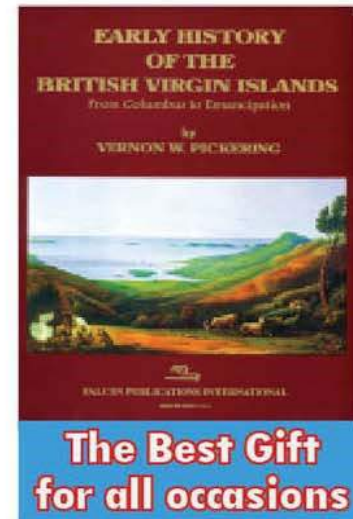
**CYBERSECURITY** - Russian cybersecurity expert Eugene Kaspersky compares the storms in Dubai with the challenges his company is facing in the United States. In recent years, his firm has come under scrutiny due to allegations about its relationship with the Russian government. In fact, the U.S. vetoed the use of Kaspersky's software by government agencies in

2017, for fear of Russian espionage. Now, the Biden administration is preparing to go further, by issuing an order that would prevent American companies and citizens from using his software. According to CNN, this is due to national security concerns. "There are things in the world that we cannot change," Kaspersky shrugs, when asked by EL PAÍS about the American government's accusations. "We need to adapt to the new reality, like with thunderstorms. [That's why] we keep working." Next, the expert boasts that his company has technologies "that recognize malware (malicious software) better than others: we do it in real-time and we send what we capture on the internet to the rest of the community. Companies like McAfee and Broadcom also exchange information. It's a kind of network of cooperation." According to this expert, failure to collaborate could reduce the quality of protection and expose users to greater risks. [El Pais]

**MOSCOW** - Vladimir Putin was sworn in as President of Russia for a fifth term in a lavish inauguration ceremony Tuesday, which included a military procession, columns of armed guards, and a cavalry parade, as well as an Orthodox prayer service.

Putin took the oath of office in the Kremlin's gilded Saint Andrew's Hall, where he was greeted by Russian officials and military brass.

While Putin was constitutionally mandated to step down in 2024,

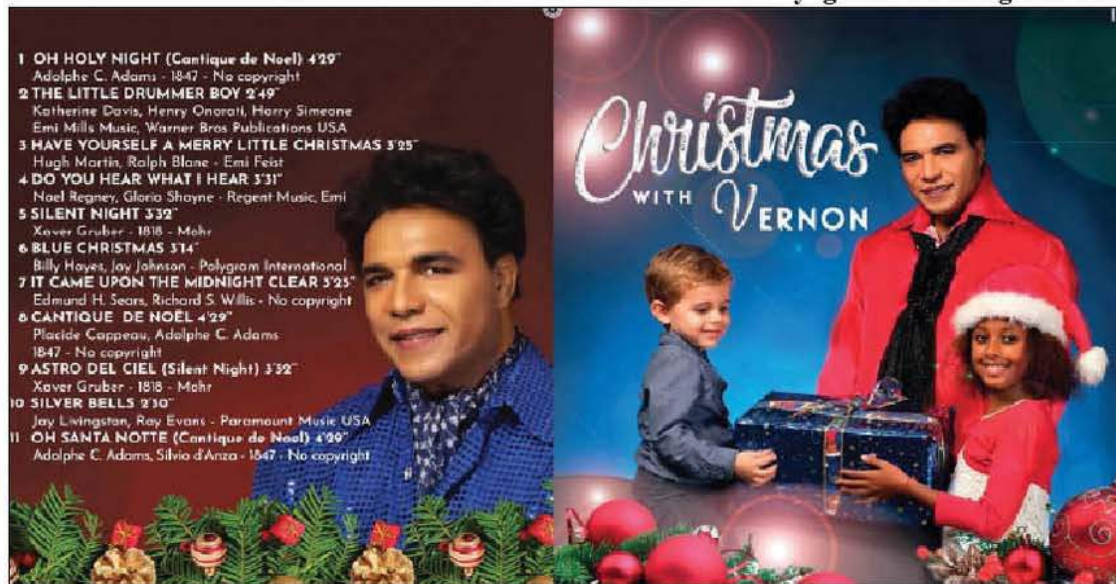

**FLORIDA** - Powerful storms battered Florida and other Southeastern states on Friday, leaving thousands without power and causing widespread damage.

Damaging winds uprooted trees and downed power lines following days of severe weather that had already brought tornadoes to Michigan, Tennessee, and other states. Wind gusts of up to 114 km/h, just shy of hurricane force, were recorded in Tallahassee. Reports are that the storm left a trail of destruction, with twisted fencing and mangled debris from damaged buildings strewn across the Florida State University baseball stadium [CNW].

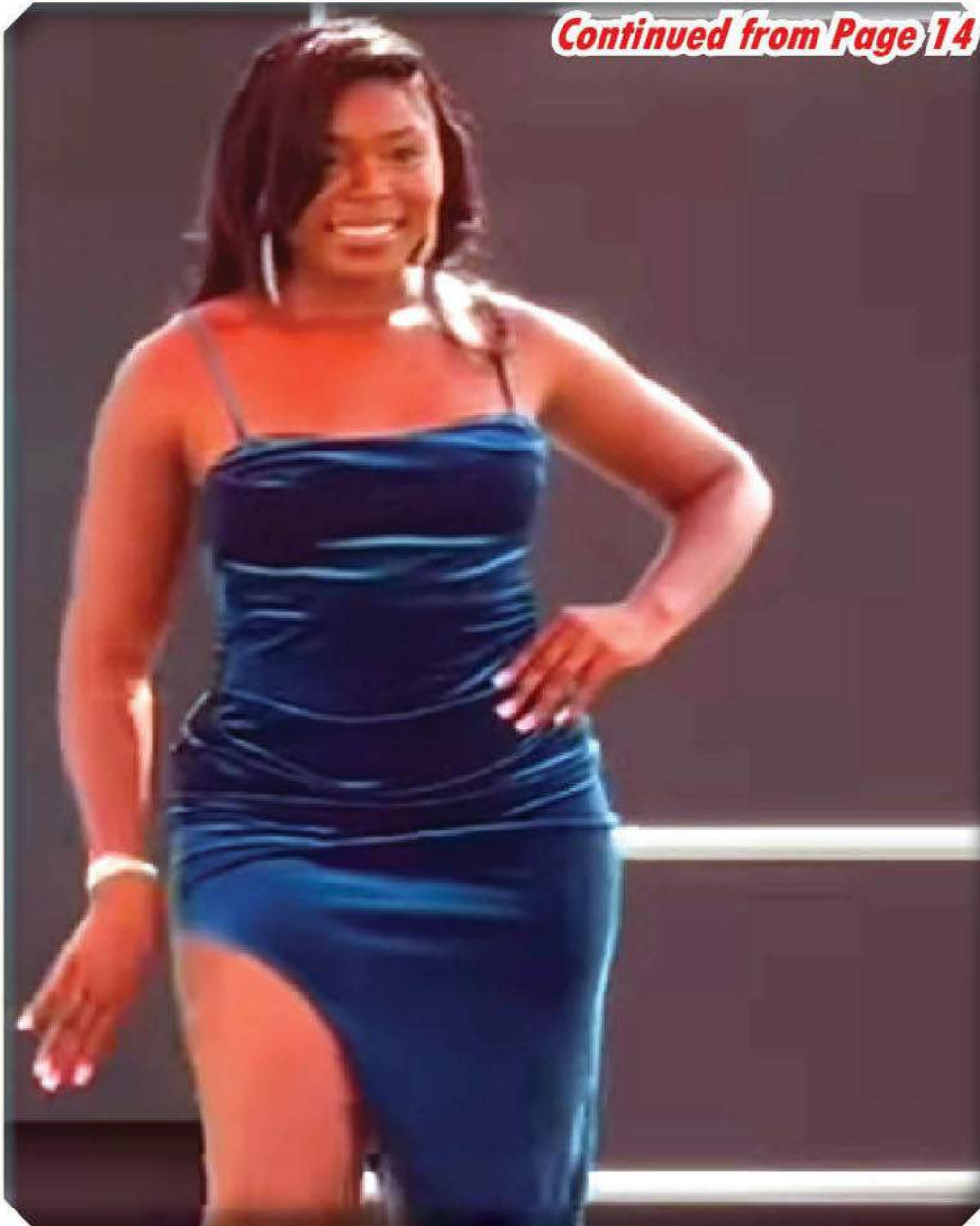

# LOCO MOCO

Yield: 4 servings

Total Time: 35 minutes

What You'll Need:

- 1 pound ground beef, at least 15 to 20% fat
- 1 medium Maui or sweet onion, peeled (1/4 of the onion chopped; 3/4 sliced)
- 2 garlic cloves, peeled and finely grated
- 3 teaspoons Worcestershire sauce, divided
- 1 teaspoon kosher salt
- 1/2 teaspoon black pepper
- 2 1/2 tablespoons vegetable oil
- 8 ounces cremini mushrooms, cleaned and sliced (optional)
- 2 cups beef broth
- 2 teaspoons soy sauce
- 2 tablespoons cornstarch
- 4 cups cooked white rice
- 4 eggs, fried, sunny side up or over easy
- Green onions, sliced, for garnish

Here's How:

Let's start with the onion. Be sure you chop a quarter of the onion and slice the rest.

In a large bowl, combine the ground beef, chopped onion, garlic, 1 1/2 teaspoons Worcestershire sauce, kosher salt and pepper. Mix until just combined, being careful not to overmix.

Shape this into 4 (1/2 inch) patties. Pop those on a plate and stick them in the fridge.

Meanwhile, in a large skillet over medium heat, warm 1 tablespoon of oil. Once it's hot, add the sliced onion and begin sauteing. You want the onion to be translucent. Stir them occasionally and saute for about 5 minutes. Now, reduce the heat to low and continue to saute the onion as it gets soft and begins to caramelize, about 7 more minutes. Remove the onions to a bowl and keep warm.

Next, retrieve the patties and add another tablespoon of oil to the pan. Bump the heat back up to medium. Once it's hot, carefully add the patties to the pan and cook them until browned, around 4 minutes per side. Transfer the patties to a platter and keep warm.

Add the remaining 1/2 tablespoon oil to the pan and saute the mushrooms for about 10 minutes. Season with salt and pepper.

Get your second skillet warming to begin frying the eggs. You'll have to do two things at once. If you are also walking and chewing gum, I suggest you stop immediately and focus.

Now, everybody in the pool! Return the onions to the pan along with the beef broth, soy sauce and the remaining 1 1/2 teaspoons Worcestershire sauce and bring to a simmer. Reduce the heat to medium-low.

In a small bowl, whisk the cornstarch with 1 tablespoon cold water until smooth to make a slurry. Add the slurry to the skillet and whisk until it thickens, about 5 minutes.

You should be cooking over-easy or sunny-side-up eggs by now.

Place the patties into the skillet to get all cozy and warmed back up.

To serve: On each plate place 1 cup cooked rice with one patty, a fried egg, then the gravy, topped with green onion. "E 'ai kakou!" (Let's eat!)

## Environmental Health Advises On Wastewater Management

The Environmental Health Division is strongly advising residents to take necessary, decisive action to remedy and improve the treatment and disposal of wastewater throughout the community.

Chief Environmental Health Officer Mr. Lionel Michael said that the poor and inadequate disposal of wastewater exposes

residents, specifically children and the elderly to several public health risks. 'Residents are exposed by walking in wastewater, being splashed by it or the inhalation of aerosols. In addition wastewater causes serious damage and destruction to public roads and property, promotes mosquito breeding and significantly increases the risk of spreading vector-borne

diseases,' Mr. Michael explained.

Wastewater includes but is not limited to: Greywater (water from showers, sinks, tubs and washing machines) Blackwater (sewage from septic tanks and soak away) Storm Water (including rain water)

The Chief advised that there are steps that can be taken to improve the treatment

and disposal of wastewater. "We want persons to design and construct an appropriate septic tank, soak-away, and treatment systems. We also want individuals to assess the current capacity of septic and soak away systems and to treat and dispose of all waste from the property," he advised.

According to Mr. Michael, septic and holding tanks should be cleaned and pumped on a scheduled basis and under no circumstances should untreated wastewater be disposed of from your property onto streets or

neighboring property.

Persons requiring additional information on the management of wastewater can contact the Environmental Health Division at 468-5110.

The Environmental Health Division is committed to ensuring that all aspects of the environment with the potential to negatively impact the health of the population are managed efficiently to enable all persons in the BVI to attain and maintain optimal health and well-being.

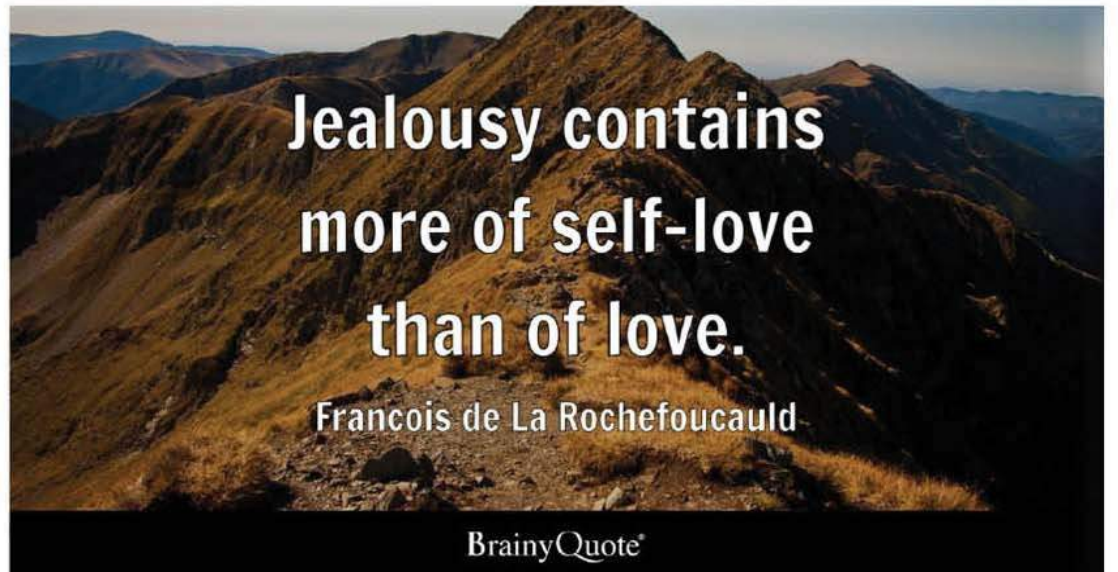
### Planning your garden size

## American Symbols

Memorial Day is a time to both honor individual memories and reflect on American history. Designers have drawn inspiration from American history for over a hundred years. Copies of styles from the early years of the American Republic, or the Federal period, have been popular since the 1870s. This is when the Colonial Revival period began, celebrating the Centennial of the United States.

Designers also celebrate American history by incorporating American symbols into their work. Stars and stripes, Uncle Sam, Lady Liberty and, of course, eagles often appear in furniture and decorative arts. Eagles are often seen as finials or crests on furniture like Federal mirrors. Sometimes they make up a larger part of a design, like this table with a pedestal base carved into the form of an eagle with outstretched wings. With a faux marble top and no identifying marks, it sold for \$163 at a Conestoga auction

**Q:** I have a collection of cards I collected as a boy during World War II. They have pictures of WWII fighter planes and bombers. The reverse has two circles with insignia or emblems. They might have been premiums in boxes of cereal. Can you give me any information and possible value?

**A:** If the pictures are just photographs, they are probably trading cards. If they have silhouettes of the shape of the planes, they might

be spotter cards, aircraft recognition cards used to identify planes during WWII. The cards had silhouettes of the types of planes used by the United States, Great Britain, Germany and Japan, as seen from the ground. They were one of the aids used by civilian observers, part of the Army Air Forces Ground Observer Corps, who manned observation posts along the East Coast, inland to the Appalachian Mountains, and along the West Coast of the United States. Reports of aircraft spotted were sent to the Aircraft Warning Service. Spotter cards were also made as playing cards and given to servicemen. Kellogg's printed "Plane Spotter Cards" on the backs of Pep cereal boxes and included a model plane in the package. Reproductions of the original spotter cards have been made. Spotter playing cards sell for about \$10. We haven't seen any spotter cards with insignia or emblems on the back. Most sell for less than \$4-\$5 each.

## Prospect Reef and a Story of Capital

Prospect reef is the perfect model for studying the subject of capital and its value in driving Virgin Islands prosperity

Now, the management of capital for increased productivity and therefore profitability is the key driver of prosperity under the capitalist system that governs all our lives.

Capital is the engine and chain that drives the wheel of a free market society. Ironically, capital also decides social and economic outcomes in non-capitalist societies where governments decide on the allocation of scarce resources, and not markets. The Virgin Islands is a capitalist country, albeit government looms large.

OK. The appropriate value and supply chains in the journey from input to output governs the capital trail. A chain is simply the process in a specific market from initial input to final output: where supply meets demand. Prospect Reef is the perfect model for adopting the idea of capital chain.

Prosperity is the result of the increase in the value of capital as it goes through

these various stages or processes of the chain from original input to final output- from initial investment to revenue and profitability. That progress is termed the value chain with the related supply chain.

Capital is a chain composed of factors such as human resources, technology and finance that drives business from start to finish: input to output. The chain proceeds symmetrically: it is linear with asymmetric impacts.

How will Prospect Reef fulfill this idea of capital as a chain of value? That is a most appropriate question to ask. Looking at Prospect as a value and supply chain will enable the project from start to finish.

It is crucial to manage value and supply chains – capital- according to the vision adopted by organizations and government, in the quest to increase revenue, profitability, and prosperity. There must be a vision of the capital mix and trail that is Prospect reef.

In order to decide on the type of value and supply chain a product or a number of inter-related products, which amounts to a market, a vision of the whole chain is imperative, from start to finish.

The chain runs from supplier and producers to consumers. The value supply chain and its links decide the culture of specific markets: in this case, it is the Prospect Reef Project.

How does the value and supply chain begin and then end its journey? A vision for Prospect Reef is a maritime

resort, hotel chain, leisure center, condominiums, and business center integrated and managed by a board. Much like the past but grander: a Pier Park Mark 2 that will employ scores of employees and managers. A boost for the Virgin Islands economy. Prospect Reef could even be a second cruise pier for small ships and mega yachts.

The Prospect Reef Project promises work in construction and project management. Then once built jobs and business opportunities for decades in tourism and retail. It must be a public private partnership.

However, will the project move from ideas on paper to reality? Will the progression of activity be a priority for government and partners? Adopting the idea of a cycle, a value and supply chain, following the progression

of the capital trail, and efficiently managed from the start to finish will drive the vision to reality. That cycle can be termed the white paper. It will require courage and decision to take the plunge.

Now the supply chain best adopts to a manufacturing type process, where there is transformation of a raw material or similar, into what the consumer wants, or the finished product. In the Virgin Islands, the fishing and agricultural industry will best adopt the supply chain as Modus Vivendi in its call to satisfy markets.

On the other hand, a value chain best describes the supply of a service, which is what the Prospect reef Project mainly offers: services to tourism and tourism oriented businesses. There is a strong link between the supply and

value chain. This writer uses both in an interwoven way, but always with the idea that it is simply the movement of capital in one form or the other, increasing in value as it advances to its final destination. The chain like the chain driving the wheels of a steam engine follows a trail decided by the vision of the project.

Managing capital and the chain of capital- technology, human resources, finance, land, and innovation- in an ordered, symmetrical, innovative, efficient, and contemplative manner, avoids error, in how critical projects are adopted.

On the other hand, ignoring the role of the capital mix and trail in social and economic development is a song to white elephants, waste, and under-development.

CARICOM Secretariat, Turkeyen, Greater Georgetown, Guyana - Wednesday, 15 May 2024: CARICOM Ministers with responsibility for trade began a two-day meeting on Tuesday, 14 May at the CARICOM Secretariat in Georgetown, Guyana.

Senator the Hon. Paula Gopee-Scoon, Minister of Trade and Industry of Trinidad and Tobago, is the Chair of the 58th Regular Meeting of the Council for Trade and Economic Development (COTED).

At the opening session, Minister Gopee-Scoon highlighted the matters on the Ministers' agenda, including the movement of Community Nationals, the status of the CARICOM Competition Commission, a mergers and acquisitions policy, trade in goods, and the review of the Common External Tariff (CET) and Rules of Origin (ROO). The Ministers will also hold discussions on CARICOM Regional Standards.

On the external economic and trade relations front, the Ministers will receive updates on the 13th Ministerial Conference of the World Trade Organisation (WTO), and negotiations on the expansion of preferential market access under the CARICOM-Colombia Trade, Economic and Technical Cooperation Agreement. Talks will also be held on the CARICOM- United States Trade Relations.

In welcoming the delegates to the meeting, Dr. Carla Barnett, CARICOM Secretary-General, underscored the "vitaly important mandate" of COTED. She noted that the meeting will consider and decide on plans and programmes that will have a significant impact on trade and business performance throughout the CARICOM Single Market and Economy (CSME). She expressed the hope that longstanding issues that are on the agenda will be brought to finality.

## Biden, Trump agree to debates in June and September

U.S. President Joe Biden and his challenger in the November 5 election, former President Donald Trump, agreed Wednesday to two debates, one on June 27 and another on September 10.

CNN said the two campaigns agreed to hold the first faceoff in six weeks at its studios in Atlanta without an audience, although other details, such as who would moderate the debate, were not announced. The second debate is being

hosted by ABC News.

The announcement for the pair of debates came together quickly on Wednesday.

Trump, a Republican who lost his reelection bid to Biden in 2020 although he still falsely claims he was cheated out of a new term in the White House, has for several weeks called for a series of debates leading up to the 2024 national vote. Biden, a Democrat, recently agreed to debate him.

On Wednesday, Biden's

campaign suggested the June and September dates, while saying he would not participate in the three debates proposed for September and October by the nonpartisan presidential debate commission that has organized the quadrennial debates for three decades.

Trump, in a post on his Truth Social site, said he was "ready and willing to debate" Biden next month and in September. CNN, the 24-hour cable news network, announced the first debate date a short time later. Both candidates immediately taunted each other, leaving decisions on parameters of the debate for another day, such as to what extent the two candidates would have their microphones shut off when the other is speaking and how long each debate would be.

"Donald Trump lost two debates to me in 2020, since then, he hasn't shown up for a debate," Biden said in a post on the X social media platform.

"Now he's acting like he wants to debate me again. Well, make my day, pal."

Trump, for his part, said Biden was the "WORST debater I have ever faced - He can't put two sentences together!"

Before June 27, a Thursday, was picked for the first encounter, Biden's camp taunted Trump, saying the Republican was "free on Wednesdays," the usual midweek day off for Trump's ongoing hush money criminal trial in New York.

In any event, testimony in the case, in which Trump is accused of falsifying business records at his Trump Organization real estate conglomerate to hide a hush money payment to a porn star just before his successful 2016 campaign, is nearing the end, with jury deliberations to follow.

The trial most likely will be over in the next two weeks or so.

As it stands, the CNN

debate will be between Biden and Trump only, although the network left open the possibility that an independent candidate, Robert F. Kennedy Jr., or another third-party candidate, could meet a 15% polling threshold and ballot access requirements to join the debate stage.

Both Biden and Trump have been wary about Kennedy's candidacy, fearing he could capture enough votes in key political battleground states to tip the national outcome.

In the U.S., the national popular vote does not determine who becomes president. Rather, the election is essentially a state-by-state vote, with the winner in each of the 50 states winning electoral votes to determine the overall outcome.

The most populous states have the most electoral votes and thus hold the most sway in determining who wins the White House for a new four-year term that starts January 20.

## Slovakia's prime minister shot, in life-threatening condition

Slovak Prime Minister Robert Fico is fighting for his life after he was shot Wednesday afternoon following a Cabinet meeting in Handlova, his Facebook profile says.

Fico was "shot multiple times and is currently in life-

threatening condition," the Facebook message reads. "At this moment he is transported by helicopter to Banská Bystrica, because it would take too long to get to Bratislava due to the necessity of an acute procedure. The next few hours

will decide."

The 59-year-old prime minister was hit in the abdomen after four shots were fired outside Handlova's House of Culture, where Fico was meeting with supporters, local media reports said.

Police have detained a suspect, according to TA3, a local media TV station.

A helicopter was sent for the leader, emergency services said.

The left-wing populist prime minister returned to power for the fourth time last year after his party won the parliamentary election on a pro-Russian, anti-American platform.

Slovak President Zuzana Caputova denounced the attack.

"I'm shocked," she said. "I wish Robert Fico a lot of strength in this critical moment

and a quick recovery from this attack."

U.S. President Joe Biden said the attack was a "horrific act of violence."

"Our embassy is in close touch with the government of Slovakia and ready to assist," Biden said in a Wednesday statement.

U.N. Secretary-General Antonio Guterres strongly condemns the "shocking attack," Farhan Haq, a spokesman for the secretary-general, said at a briefing. Some material in this report came from The Associated Press, Agence France-Presse and Reuters.

## Wolues fend off Islanders, 3-2, for 1st BVIFA league title

Reigning President's Cup champions Wolues fended off eight times BVI Football Association league champions Islanders, 3-2, and laid claim to their first title on Sunday in Greenland.

Captain Phil Nelson put Wolues on top in the fourth minute and Kieran Bown made it 2-0 in the 39th and into halftime.

Oswort Holder got Islanders on the board in the 51st then Antonio Rodney equalized the game at 2-2 in the 60th. "Just a fantastic achievement

really. We've been working so hard this year. It's a combination of many years of a great squad, a great team and we're very pleased to have won it," Coach Nick Messum told Island Sun Sports, noting that they didn't give up when Islanders tied the game in the 66th. "We just didn't give up. We reorganized in the second half, went 4-3-3, got another goal and really just held on. They had lots of chances, but I think we've been the better team this season."

Islanders Coach Fitzroy Daley said they started off shaky, then got into the game. "I think the bearing of the game could have been better in terms of refereeing—I'm not going to blame it on the referee totally—but they made some calls in crucial stages that determined the outcome of the game," he said. "Well done to Wolues, they played well. They came out, did what they had to do, they did the job and we lost the game."

Islanders—who were seeking their 9th league title—won 12 straight

games, changing their way and style of play, Daley noted.

"We're coming together as a team, we're playing good football, so that's where it is right now," he said.

Despite losing the title, Daley said they're keeping their heads up after a well played game heading to the President's Cup.

"We're going into the knockout stages of the cup and I think we have a good chance of getting it there," he said.

Winning the league title and retaining the President's Cup, Messum said, would show how well they've been playing.

"If we could do that, it's not going to be easy," he noted. "Islanders have come up in the second half of the season. Sugar Boys, VG United, One Love, Lion Heart, they're all capable of playing, but if we win, then we deserve it."

Elsewhere, in search of a President's Cup spot, reigning league champs One Love, overpowered Old Madrid, 4-1.

whitewash of Rebels. Williams scored in the 3rd, 27th and 53rd. Joel Mars had a brace in the 45th and 74th while Jaadon Quashie scored in the 58th and Devin Jones rounded out the scoring in stoppage time.

## Gumbs twin brothers grab conference titles, Croal, Hill shine

Shot Putter Djimon Gumbs 3-peated as Southland Conference Outdoor Championships champion and twin brother Diamante repeated as Discus Throw champ, while Jaleel Croal ran personal bests for second and third respectively in the American Athletics Conference sprints and Josh Hill was second in the Conference USA quarter mile.

Northwestern State's strongman Djimon heaved the 16lbs cannonball 18.94m (62'2"), for BVI's 41st Collegiate title since 1979. Twin brother Diamante was 4th with 17.17m (56'4").

"This was an amazing competition among a great group of guys, you really had to come in on you're a game," Djimon said. "Those guys did not disappoint, I always love competing

with them. They just pushed me to get better."

In the Discus Throw, Diamante's opening heave of 56.26m (184'7") stood up and he defended his Southland Conference Championships title. Djimon's 5th round 54.51m (178'10") effort, vaulted him from 4th to 2nd, as they ended their title chase 1-2.

"To come out with a bang is what I wanted to do because I felt good in the warmups," Diamante said. "The fact that I threw so far in the first round, I was very happy and excited about that. I also wanted to extend the mark, but I had some technical inconsistencies but overall, it was a good day."

In his Javelin Throw season debut, Djimon climbed from 9th place to 4th, with a sixth round effort of 53.79m (176'6"). Djimon and Diamante have combined to win eight Southland Conference Indoor and Outdoor Championships since 2022. Djimon won the Shot Put outdoors in 2022, 2023 and 2024 and Indoors in 2024. He won the outdoor Discus Throw in 2022.

Diamante won the Weight Throw Indoors in 2022 and the Discus Throw outdoors in 2023 and 2024.

After a stellar 2nd leg carry that helped the South Florida Bulls 4x100m Relay to an American Athletics Conference Championships 38.44 seconds meet record and No 2 NCAA time, Jaleel Croal ran a 100m personal best of 10.13 seconds (+0.8) and finished 2nd. He won his heat in 10.36 seconds, (-0.5).

On Sunday, he dropped a 200m personal best of 20.47 seconds (-0.20) and placed third, helping the Bulls to a complete sweep of the event, enroute to winning the conference championships.

By finishing second in the Conference USA 400m, Josh Hill completed UTEP's 1-2 finish, with his second best time of the season of 47.03 seconds. He advanced after running 48.53.

Grayson High School Sr. Kijana Callwood, won the Georgia State High School Girls 7A State Championships Discus Throw, when she flung the

platter, 42.49m (139'5").

### Pro scene

Kyron McMaster made his 400m Hurdles season debut, with a second place finish in the Jamaica Athletics Invitational. He had a time of 49.00 seconds.

A leap of 6.53m (21'5¼") with a legal +1.7 wind, has put Chantel Malone in the chase for one of the 32 spots in the Paris Olympic Games. It's the second meet of her comeback after a 2-year recovery from injury and rehabilitation.

"I'm so grateful to even be back. For the last two years, I've had that start stop, start stop dealing with my knee and then ultimately having that surgery," Malone told Island Sun Sports. "It was a lot to deal with mentally, so to be able to come back and produce even that (6.53m) with errors, that's just a blessing and I really thank Jehovah God for keeping me in the game, because a lot of people would have tapped out."

She said the 6.53m improvement

on her 6.26m (20'6½") opener is a testament to where she is because of the errors she made. "In my opinion, this meet should have been a 6.7+ at least, if I'd done what I did correctly," she noted. 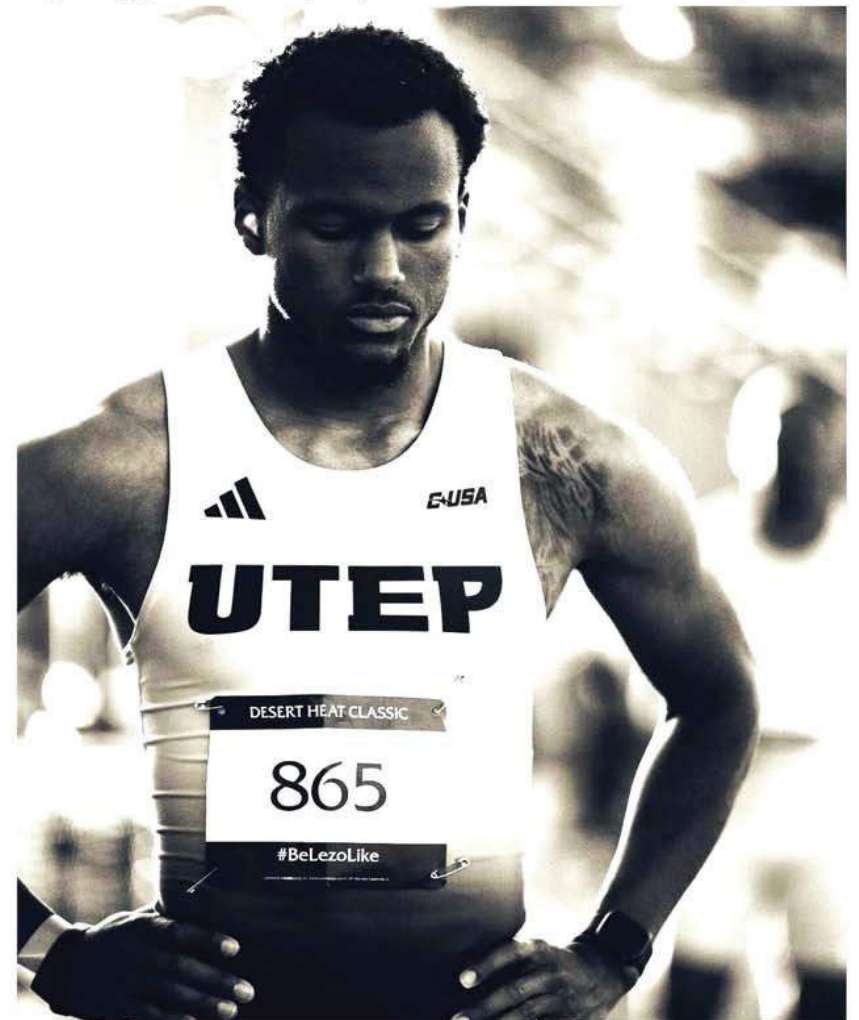

## Immunotherapy for Peanut Allergies Still a Work in Progress

**DEAR DR. ROACH:** Why can't people see an allergist and get desensitized to a peanut allergy? As a child, I was allergic to dust, pet hair, milk and other things, but I received treatments. I am not bothered by any of these now. It would seem prudent to desensitize people who have allergies that are life-threatening, like peanut allergies. — S.S.

**ANSWER:** Allergy immunotherapy continues to be a commonly used and valid treatment for many allergies, including environmental allergies, insect venom allergies and, more recently, food allergies. The treatment can be used for peanut allergies, but it is certainly not perfect. So, it isn't used very often.

The goal of immunotherapy is to get a person to tolerate the allergen that they have an allergic response to. This involves giving very tiny amounts of the allergen below the level that would trigger an allergic response. Over time and under extremely close observation, the amount of the allergen is increased. For allergens like pollen, they are typically given by injection under the skin (or by drops under the tongue), but for food allergens, they are given orally.

For peanut allergies in particular, reactions are common during oral immunotherapy. For about 1 dose per 1,000 under supervision in an allergist's office, emergency treatment with epinephrine was required. Even during maintenance

therapy at home, a reaction occurred 3.5% of the time, requiring treatment with 0.7% of all doses.

Although oral immunotherapy is effective at getting people to tolerate peanuts, the effectiveness is not long-lived, with only 13% of people still being able to tolerate a peanut challenge three years after discontinuing maintenance therapy. (Thirty-seven percent of people who continued maintenance therapy were able to tolerate the peanut challenge.)

Until there are significant improvements in outcomes, I am unlikely to recommend oral immunotherapy for people with peanut allergies, unless they are unable to effectively avoid exposure to peanuts and they continue to have repeated reactions. Whether they're on immunotherapy or not, patients are still advised to continue careful avoidance and have emergency treatment immediately available.

A new treatment for food allergies was just approved by the Food and Drug Administration. Omalizumab works by blocking the immunoglobulin IgE, which is critically important in allergic diseases. The study showed that 47% to 80% of subjects who were treated with omalizumab for four months (given by injection every two to four weeks) were able to tolerate a standard dose of the foods that they were allergic to (peanuts, plus at least two other foods).

However, it appears that the benefit of the treatment does not persist after the treatment is discontinued, and it is intended for use in conjunction with food allergen avoidance to protect against accidental exposures.

In the future, combining this new medication with oral immunotherapy could be superior to using either alone, and it can help prevent serious or fatal allergic reactions from inadvertently being exposed to peanuts. Further studies are addressing this issue.

true. The body retains the fluids because it isnt getting enough fluid and tries to hang on to what it gets.
